

## EUROPE IS LOSING

For those who have not noticed yet, there is a clear message written on the wall: Europe, in its guise as the emergent European dis-Union (EdU), is losing ground faster than anyone could have thought possible only a few years ago.

The main causes of this rapid degeneration are three: Germany's fixation with austerity and the resultant catastrophic economic crisis that threatens the wellbeing of all Europeans; the breakdown of border control and the Moslem "irregular migrant" invasion; and the refusal of core European governments to accept that there can be no peaceful co-existence with Islam, either in its "home-grown" garb or the blatant murderous form of *jihad*.

There are several subtexts underlying these three main causes.

The EdU Western European core, plus the Brussels mandarinat, is pre-occupied with the politics of "inclusion" and "politically correct" attitudes and behaviors. These fixations, originating in the 1960s, have diluted, if not neutralized, efforts to deal with the *real problems* and correctly assess risks and threats growing under these governments' very noses.

EdU senior politicians, with Angela Merkel leading, are helplessly caught in irrelevant debates about the future of European "unity" when the very social, political, and educational fundamentals of a long European history, beginning with Christianity, the Enlightenment, and classical education, are subject to murderous attacks by "radicalized" domestic Moslem minorities that remain immune and unscathed lest politicians and the non-Moslem public are found to be "Islamophobic."

European leaders have been misled by their own moral and intellectual inbreeding about "equality" and "integration" leading them to overestimate the value of the so-called "soft power" and abandon politically in-correct security, including aggressive intelligence gathering and preemptive measures.

Decades of bureaucratic interventionist "rationalism," which was defined as necessary in order to force the emergence of a more equitable society, have devastated Western moral traditions, community loyalties, and national histories as guideposts of the present and future.

No matter how dangerous an imminent threat may be, this “rationalism,” coupled with soggy liberalism, defines those advocating in favor of *real time defenses* as incomprehensible paranoids motivated by ignorance or evil or both.

Muddled “humanist” policies add insult to injury. The Moslem onslaught that poured out of Turkey in the summer of 2015 was met not by a fundamental proactive strategic shift but with more of the same EdU pitiable medicine: proposals for changed asylum rules, more money for “hotspots,” quotas for “re-settling” refugees nobody really wishes to accept, and the convenient solution of turning one member state (Greece) into Europe’s rubbish dump to hold the unwanted.

Europe is busy defining what *cannot be done* while what *must* be done remains unexplored. An eye-popping example of this attitude was delivered by Mrs. Merkel, with senior EdU leadership figures in tow, visiting Turkey to show European commitment to ala cart “humanitarianism” in collaboration with an unabashed Islamic regime.

Mrs. Merkel found cause to praise Turkish efforts to check the “migrant” crisis Ankara *deliberately organized and promoted*; and Mr. Donald Tusk effusively described Turkey as a shining example on how to treat refugees in this day and age.

The EdU delegation’s fervor in finding Turkey the indispensable ally in saving European politicians from upcoming painful electoral defeats was hard to hide. This disgraceful pantomime unfolded while Turkey’s president and prime minister both openly *threaten* the EdU with unleashing more waves of Moslem “irregulars” upon Europe if Brussels does not remove all restrictions for visa free travel to Europe by Turkish citizens.

Europe is losing.

We see the signs of this rapid decline with every passing day.

Weak-stomached moralism replaces truth. Prejudice against one’s own history and tradition and pervasive inability to comprehend what is *truly* at stake, aside from individual politicians’ fear of losing their seats, command the public forum. Non-stop efforts to eradicate competent intelligence in favor of hollow liberalist mantras, with no other aim than shaping an incompetent, silent populace, define the headlines.

If Europe wishes to survive, it *must* change tack before it is too late.

It must ditch its rose-tinted spectacles and stare at the world with the naked eye. It must comprehend that moving two thirds of the Third and Fourth Worlds within European confines *is not policy but suicide*. It must understand that “diversity,” as randomly defined by flummoxed government “experts” and scheming politicians, with a stake in using the “diverse” for their own personal purposes, is not/is not acceptable. And it must *resist* officially sanctioned interpretations of what is authoritative and desirable when *growing popular majorities* begin to reject these tin-plated constructs.
